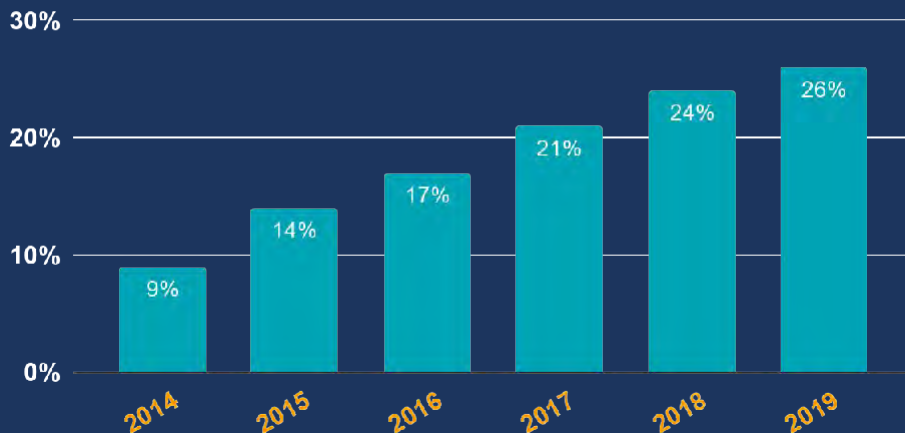

A \$1,000 major gift? \$70 lost to fees.



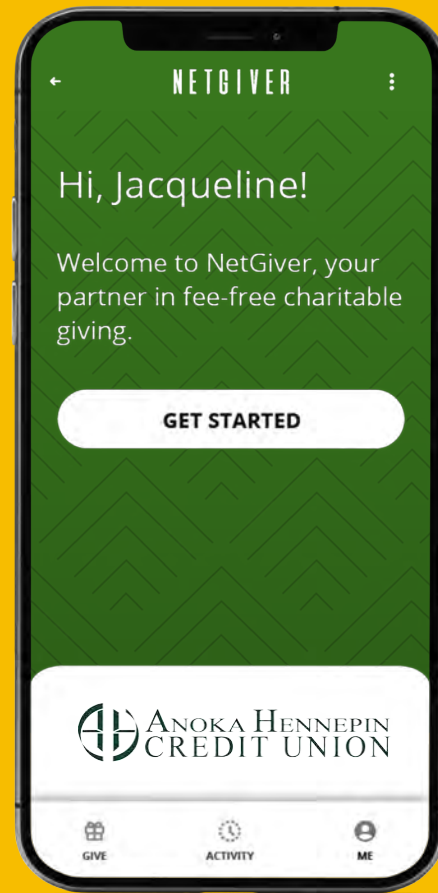
